Andrews, Interim Chief Procurement Officer and Reshma Soni, Comptroller.

requesting authorization that the Chief Procurement Officer (CPO) and the Comptroller be granted limited authority to approve, process and execute payments to vendors and contractors from FY 2012 for goods and services received by the Cook County Using Departments and Agencies without the prior approval from the Office of the Chief Procurement Officer (OCPO).

Reason: Upon the appointment of Shannon E. Andrews as Interim Chief Procurement Officer, she learned that the OCPO, the Chief Financial Officer (CFO), Comptroller's Office, President's Office and State's Attorney had engaged in several meetings and discussions to address using agencies and departments, who for a variety of reasons, procured goods and services from vendors and contractors during FY 2012 without receiving the prior approval from the OCPO.

Several measures and procedures have been implemented in order to eliminate unauthorized procurements going forward. In August 2012, the CFO issued a draft memorandum to using agencies and departments providing that the OCPO would not process payment or requisition requests for goods and services obtained without the prior approval of the OCPO. In December 2012, the CFO, OCPO and Comptroller's Office issued additional memoranda concerning the procurement process, and which goods and services are eligible for direct payment. Finally, on

December 18, 2012, the OCPO issued the first release of the Procurement Manual, which further addressed the process for direct payments and emergency procurements.

The OCPO is currently working with the CFO, Comptroller, and President's Office to identify instances in which using agencies and departments have requested payments to vendors or contractors who provided services or goods prior to the using agency or department receiving approval from the OCPO. Additionally, the OCPO has requested that each using agency or department complete a certification form for each instance in which they have requested payments to a vendor or contractor, who provided goods or services prior to the using agency or department obtaining the approval of the OCPO. Finally, the OCPO is working with the State's Attorney's Office to identify the instances in which the Cook County Procurement Code authorizes the OCPO to process payment requests to vendors and contractors within the existing authority of the OCPO.

The OCPO and the Comptroller are requesting limited authority to process and execute payments to vendors and contractors from FY 2012 for goods and services received by the user agencies and departments without the prior approval from the OCPO. The OCPO will provide a report to the Board of Commissioners of all such requisition or purchase order requests that would be approved under this limited authority prior to the processing the payment of any such requests; the OCPO anticipates providing such a report no later than February 25, 2013. On or before March 31, 2013, the OCPO and Comptroller anticipate processing payments for the procurements identified by the OCPO by February 25, 2013 and authorized under this limited authority.
